113/14. Apologies for absence- Emma Parker

114/14. Public Participation –. None

District Councillors Report provided by Jane Somper included details of funding available towards restoring village fingerposts (which WW has one –roundel only-at bottom of Blandford Hill by bus shelter). Also current issues with bin left untidy and scattered after refuse collections.

115/14. Approval of Minutes- The Minutes of the meeting held on 1st October 2014 had been previously circulated and were now approved and duly signed.

116/14. Matters Arising-

CSW report by AT advising the speedwatch team had been out 5 times in October and 43 vehicles reported to the police travelling in excess of 36mph.

The new noticeboard is almost complete and the PC need to decide on where it can be placed as the wall on the village hall is not now available as originally agreed.

The LB bus shelter is due to start being rebuilt provided the weather improves.

It was also confirmed (refer 92/14- 01/09/14) that a smaller noticeboard would be purchased value up to £100 and placed in the brick bus shelter at the bottom of Blandford Hill. The Clerk to arrange this.

Further investigations ongoing regarding ways to slow the traffic down in Chescombe and Whatcombe Lanes.

The clerk is still chasing DCC Highways about the grass cutting of roundabout in Fields Close.

It was agreed that the clerk would contact the local County Councillor regarding the delay in DCC signing their part of the new Play Park lease as superior landlords.

117/14 Recruitment for new Parish Councillors--It was agreed that CW would place an advert in the February edition of the Village News

118/14. The clerk provided details of a firm that build web sites and it was agreed that he would contact them for information regarding providing a Parish Council Web site for the village.

119/14. British Legion Wreath-it was agreed that the PC would lay their wreath on Tuesday 11/11/2014 at 11AM. It was also suggested that the PC donate £50 to the Royal British Legion –proposed by CW 2nd by AT all agreed.

2/2014/1296/TPTREE: 9 St Mary's Close, Winterborne Whitechurch, Dorset, DT11 0DJ

Proposal: T1 - Whitebeam in front lawn - These works do not fall within the TPO area therefore works can go ahead without notification to the Council.

T2 - Oaks x 2 - Reduce by 4m width and 3m height leaving pruning wounds of no more than 50mm. Branches overlapping into adjoining tree and neighbours trees.
